Uppsala, Sweden Conference schedule (Updated: 22 June 2023)

Wednesday, 28 June 2023

A walking tour of the historic city of Uppsala. The tour begins at 10:00 AM (sharp!) at the entrance to the Cathedral (*Uppsala domkyrka*) and includes visits in smaller groups to the Treasury (*Skattkammaren*). We will have lunch at the Cathedral café at a reasonable extra cost, and then continue on foot. We will see, among other things, the main University building, and its park, the University Library, the Castle and the baroque garden, and the so-called Prince's House (*Prinshuset*), where several Swedish princes lived when they were students at Uppsala during the second half of the 19th century. The tour is not included in the conference fee.

Participants who have visited the Treasury are allowed re-entry during the subsequent days.
